Rules and Bylaws

ARTICLE I.... Purpose, Name, Mission, Vision, and Values

Purpose

Section A:

1. To make available a place for local anglers to organize, collaborate, and compete in pursuit of positive sportsmanship and fellowship.
2. To improve the skills of anglers through the sharing of ideas and education regarding fishing techniques, locations, baits and more.
3. To contribute positively to the community by means of fundraising and education.

Name

Section B:

1. The name of the organization shall be “Longview Bass Club LLC” known in this document as “the club”, and “Longview Bass Club”.

Mission

Section C:

1. Promote bass fishing conservation efforts.
2. Provide a safe, fun, and competitive bass fishing environment.
3. Provide a place for likeminded anglers to improve their bass fishing techniques.
4. Help promote fellowship in the community.

Vision

Section D:

1. To be an organization that transforms into a community of like-minded competitors, that will help promote the sport of bass fishing in a way that is positive and open, while giving back to the community.

Values

Section E:

1. Conduct ourselves in an ethical manner with integrity, respect, and fairness in all matters.

ARTICLE II.... Membership

Induction

Section A:

1. Must fill out Club Application and emergency contact form.
2. Must meet requirements stated in Article II, Section B.
3. Must be in good standing with community.
4. Must be approved by President and Membership Commissioner.
5. Must become or agree to become a B.A.S.S. member.

Qualifications

Section B:

1. **ANY BOATER(DRIVER) OVER THE AGE OF 18, NONBOATER MUST BE AT LEAST 13 YEARS OF AGE OR OLDER (UNLESS HE OR SHE IS A SIBLING. NO AGE REQUIREMENT FOR SIBLING-NONBOATER). ALL MEMBERS UNDER THE AGE OF 18 MUST HAVE A SIGNED CONSENT FORM ON FILE WITH CLUB. ALL MEMBERS MUST HAVE BASS ID NUMBERS PROVIDED TO PRESIDENT PRIOR TO FIRST TOURNAMENT.**
2. **OUTBOARD MOTOR OF 60 HP OR GREATER AND BOAT LENGTH OF 16FT OR GREATER.**
3. Willingness to abide by the rules of conduct and competition set forth by the club.
4. Must have proper safety equipment on boat per state law and regulations.
5. Payment of annual dues and tournament buy-ins.
6. If you have not provided guide service for pay in the last 2 years.
7. Must have a working livewell. Livewell checks will be made during the season. Noncompliance with this rule can lead to removal of the club.

ARTICLE III.... Removal of Membership

Reasons for Removal

Section A:

- 1. Cheating in a tournament will result in the immediate dismissal with 0 refunds of club tournament dues as well as yearly dues. All points for the year will be dismissed, along with removal of club membership.**
2. Refusing to abide by the current rules and policies will result in dismissal.
3. Display of bad sportsmanship
4. Flagrant disregard of boating safety.
5. Any other act that would reflect dishonor or disgrace the club or its members.
6. Other reasons for dismissal will require a majority vote by members of the board that are present at the given business meeting, after formal protest.

ARTICLE IV.... Dues

Yearly, Tournament, Club Classic

Section A:

- 1. Club dues are \$80 a year per PERSON, (THIS PRICE IS NOT INCLUDING YOUR BASS MEMBERSHIP,) Members are required to purchase their own BASS Membership and provide President with their BASS ID # prior to the first tournament. If not, he or she will not be permitted entry into the club. There is an \$80-per tournament buy-in per TEAM for regular season tournaments. (Team defined as no more than 2 people per boat). The Club Classic is \$100 per team for tournament buy in.**
- 2. B.A.S.S Nation affiliation due for each member will come out of his or her \$80 club due. B.A.S.S affiliation is \$30 a year. (Unless promotions by BASS causes membership fees to be lower, see ARTICLE IV/SECTION A-1.)**
- 3. 5\$ of the \$80-per team tournament buy-in will go to the club for year-end rewards/trophies. After the club dues, 20% of the entry will go to Big Bass. (Big bass 5lbs+with rollover if bass of given size isn't caught in the tournament.)**
4. Yearly dues will be used for year-end trophies/equipment/giveaways.
- 5. The Club Classic will have a one-time \$100 team buy in, with 20% of the buy-in going to the overall Big Bass caught during the Club Classic. (Does not have to be over 5lbs during the Club Classic).**

ARTICLE V.... Club Rules

General Club, Tournament, House Rules

Section A:

1. **No more than 35 teams per club season.**
2. **A team may consist of 1 boater, but no more than 2 boaters on a single vessel. If member is fishing solo, he or she must still pay the \$80 team buy in price for tournament. A boater may have 1 guest, FREE to fish with them during the season. If the club member fishes with more than one guest a year, that guest will pay a \$50 guest fee to fish our club tournaments in addition to the team tournament fee of \$80 for a total of \$130. Cannot fish more than 3 tournaments with a guest fishing partner-
PER TEAM**
3. Teams may have only 5 bass in the livewell at a time. If a 6th is caught the team must cull a fish. Each boat **MUST** have a working livewell.
4. Only black bass (spotted, largemouth, Guadalupe, Florida, Alabama) are allowed to weigh. If you are unsure you may request to use the club's courtesy measuring stick. If you or your partner have a under 14-inch fish in your 5-bag limit and bring it to the weigh station to weigh, you will be disqualified from the tournament and your weight for that tournament will not apply to your teams' total points at the end of the year.
5. **ALL BASS MUST BE 14 INCHES OR LONGER.** (except for slot lakes, **even spotted bass**).
6. All club members must have a valid fishing license.
7. Life jackets must be always worn when the motor is running and in gear.
8. All club members must respect the no-wake zones at each respective lake. Disobeying no-wake zones could lead to DQ by President and board.
9. Boaters must always drive safely. Protests heard by the President and officers can lead to dismissal or DQ for the tournament and or club.
10. Club members are responsible for keeping a current boating registration, and current insurance.
11. **Local, state and federal laws will be followed, and all members and members' guests shall abide. If not, members may face criminal/civil charges and or removed or disqualified from the Longview Bass Club.**
12. Kill switches must be utilized during tournament for boater safety.
13. There will be an honor system in place for boaters to not cast until the agreed to voted time for first cast. (Will be voted on in the monthly business meeting)
14. **Any club member is suspect to a livewell check by the President, board member or tournament officer. Failure to comply will result in DQ for the tournament and possible club.**
15. **Dead fish will result in a 1lb deduction of the team weight (conservation will be a focus in this club). If a Big Bass contending fish is caught, and unfortunately is dead, the 1 lb. deduction will come from that fish. (example: 5.5lb bass is caught, is dead, fish no longer eligible for big bass, it's a 4.5lb fish)**
16. Emergency contact form must be filled out prior to first tournament of the year. Membership Commissioner will keep on file in case of emergencies.

17. Club members must put their chip on Club Board prior to launch (GREEN), and upon return, turn their chip to RED. Chips must be RED at weigh in time, if not, members will be disqualified for the tournament. If not turned to RED and member cannot be located, members will be called for wellness check. Members are responsible for their chip and must pay for replacement if they lose it.
18. If a team must leave tournament early, they must flip their chip and leave note, or text President or other board member.
19. **No consuming alcohol. All local and state laws will apply to these acts. It is our responsibility to the community and youth to act in a way that does not misrepresent the type of men or women that we really are. Drunkenness of any type will not be tolerated at weigh-ins. This is to be a family-friendly atmosphere for all.**
20. Team names will have to be approved by Membership Commissioner or board member before it can be used in writing or on club's website.
21. The Longview Bass Club will not be a social club in which solicitation of any type of legislation or political candidate will occur. If a member is found to be doing so, he or she could be voted out of the club by board members at the next monthly business meeting. No federal, state, or city political solicitations or attempted influences in legislation will occur in the club.
22. **Lake "off-limits" times will run from the Sunday 5:00pm the weekend before the tournament, until tournament date. (Typically, 5:00p.m. Sunday-Tournament date-5days) At this time the lake is off limits and cannot be fished or boated on.**
23. Trailing is allowed, due to the honor system of the "time of first cast" rule. However, a designated weigh in site will be determined at the monthly meetings.
24. **The Club Classic will consist of a 2 day tournament, SAME LAKE. The lake of choice will be drawn from a hat. The lakes to be drawn from are the lakes not fished during the season. It is a president's discretion whether the Classic is to be moved. During the drawing a second lake will be drawn as a backup location. (low water level, safety, and etc.)**
25. **The Classic Lake drawing will occur at the meeting prior to the last regular season tournament, thus giving anglers enough time to pre-fish for the classic.**
26. **Anglers MUST FISH a MINIMUM OF 6 TOURNAMENTS TO QUALIFY FOR THE CLASSIC. (RAINOUTS ARE AT THE DESCRETION OF THE CLUB AND BOARD)**
27. **THE Club Classic will not result in points going toward the AOY awards.**

ARTICLE VI.... Protests

Procedural Protest Method

Section A:

1. **If a member perceives a violation of the rules for a tournament, they have up to 15 minutes after weigh-in has concluded to file a protest.**
2. The member will be interviewed by the President, and board members, that are present, unless one of the board members are either the member protesting, or the member being protested.
3. The President and board will also interview the member being protested and after hearing both sides will make a ruling. All rulings are final. If a protest is not filed within 15 minutes of the end of weigh-in, the motion will not be considered.
4. The President will have the discretion to determine the need for a polygraph/truth verification examination if there are concerns over rules violations. The president and board members will arrange for an independent expert to administer and interpret the results and establish the scope of the questions to be asked during the examination. In the event a competitor refuses to take or fails to pass the examination, he/she will be disqualified from the event in question and other disciplinary action taken as deemed appropriate by the board and the president.
5. **Any member protesting a decision made by the board or President has 72hrs (3days) to officially bring it to the board, and president's attention. The president and board will convene to discuss such protest. Decision is to be made in no later than 72hrs (3days). The board and president will use the 3 following criteria to come to a decision.**
 - **Is there a matter of safety, or is action safe?**
 - **Is there a matter of fairness? Is the action fair for EVERYONE in the club?**
 - **Is there a matter of performance? Does the action or protest involve decreasing the chance of CLUB performing better or worse? (Will club catch less fish or more? Action must be equal to or improve performance)**

ARTICLE VII.... Payouts/Scoring

Payouts

Section A:

1. The club will payout for 3 spots **(50/30/20%)**.
2. Payouts will be given to the winners at the following month's team business meeting.
3. Desire to payout more spots can be met with a vote after the season is over, or at the beginning of the season, prior to the club season.
4. **For the 2024 Season the club has voted to have increased pay-outs for the Classic. Thus, Club Classic 2024 will be a \$100 team buy-in. The preliminary payout for the classic will be as follows:**

1st-\$1000

2nd- \$600

3rd- \$400

Big Bass- \$300

The payouts for the Club Classic can change from year to year based on membership as well as club funds. The target of the club is to maintain these payouts for the Classic, however the Clubs funds for payouts of the AOY's will take priority over Club Classic payouts. Members will be kept up-to-date of changes, however club funds are at the discretion of the President.

5. AOY's for the season will split \$1000

- **1st \$500**

- **2nd \$300**

- **3rd \$200**

- **Lunker of the year-TBD**

(THESE PAYOUTS ARE LIABLE TO CHANGE DEPENDENT UP MEMBERSHIPS, THESE ARE THE MINIMAL NUMBERS FOR 2024 SEASON)

Scoring

Section B:

1. A points system will be setup for scoring. See example:
1st- 50pts
2nd- 49pts
3rd- 48pts
4th- 47pts
5th-so on
2. Anglers fishing the tournament but not weighing fish, will receive 10pts less than the club team weighing in the fewest pounds.
3. Points will be added together over the course of the season, and the team with most points will win Team Angler(s) of the year trophy.
4. Big Bass will be recorded throughout the season and the club team with the biggest bass will win Lunker of the Year Award.
5. One lowest team score from a team tournament will be dropped at the end of the year, prior to finalizing year end scores.
6. Ties will be decided by coin flip. All decisions of the President or club board members are final.

ARTICLE VIII.... Meetings

Meeting Agenda

Section A:

1. Meetings will be held the next to last weekend of the month.

2. Club's raffles will begin at this time, with results and prize giveaway at the club's tournament.
3. After January, the tournament weekend will be the weekend after the club's business meeting unless communicated by the President.
4. The club's website as well as its social media pages will communicate any changes that may take place due to weather, and possible multi-tournaments going on at the same date as the Longview Bass Club's tournament.
5. The "first cast" time will also be voted on during this time.
6. The weigh-in boat ramp will also be discussed and voted on if necessary.
7. Buy in's will be collected at this time. **Buy in's can also be collected day of tournament but must be at least 30 minutes prior to first cast.**
8. Payment to winners for previous tournament will be made at the monthly business meeting.
9. A club financial breakdown will be made at this time.
10. This is the time for members to voice concerns, ideas, fishing techniques, etc.

ARTICLE IX.... Finances

Club Spending and Planning

Section A:

1. All fees and organizational funds collected shall be used for the following:
 - a. Club equipment and permits.
 - b. Club website, postage, publications, and literature.
 - c. Club event payout, prizes trophies, plaques, etc.
 - d. Club banquet awards.
 - e. Contributable donation to an organization that helps the community.
 - f. Any other use for the club as decided by the club board.
 - g. The club president will carry over adequate funds as an operating reserve to ensure future budget obligations will be met without a deficit or shortfall in funds. Every effort should be made to distribute funds collected in the same calendar year.
 - h. No monies by the organization will be given to ANY electoral candidate, or to any electoral campaign regarding local city, state, or federal candidates. Monies will NOT be donated for any election, anywhere.

Fundraising

Section B:

1. Raffles will be held often during the club season. The monthly business meeting will include a raffle to buy into different baits/products with the drawing for the winner being at the tournament after the weigh in.

2. 50/50 raffles may also occur during the club season. Which raffle or combination of raffles used may be voted on by the club during the monthly business meeting.
3. Sponsors are welcomed and will be treated with the utmost respect. Final authorization for sponsorships will be made by the President.

Conflicts of Interest

Section C:

1. Any possible financial conflicts of interest must be brought forth to the board.
2. After disclosure of the financial interest and all material facts, and after any discussion with the interested person, he/she shall leave the board or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining board or committee members shall decide if a conflict of interest exists.
3. If the board cannot decide, an investigation by a disinterested party may take place to make a fair decision.
4. The board may hear from the interested party and take into their considerations and allow him or her to explain themselves.
5. Upon that, a vote of disinterested board members and officials will take place to help resolve any issues involving any type of financial conflicts of interests.
6. Any member that does not disclose a possible financial conflict of interest will be asked to explain themselves and if voted on by disinterested board members, will be removed from the club, and or any of the possible financial transactions or arrangements will be dropped, or voided.

ARTICLE X... Hierarchy

Board Leadership

Section A:

1. The club's board will consist of:
 - a. President/Director
 - b. Vice President
 - c. Secretary
 - d. Membership Commissioner (MC)
 - e. Officer
 - f. Officer

Board Responsibilities

Section B:

1. **President/Director**- over-sees launch, livewell checks, and help with weigh ins and gives payouts at the monthly business meeting. Works with staff with

raffles and communicates directly with members via text, social media, and meetings. Leads business meetings with club members.

2. **Vice President**- fills in for President in his absence. Is knowledgeable in all aspects of the raffle and weigh-in. Helps the recording process during weigh in.
3. **Secretary**- helps with weigh ins, sponsorships, and maintains website and social media pages.
4. **Membership Commissioner**- helps with buy-ins and membership applications and weigh-in.

Elections

Section C:

1. The President of the Longview Bass Club is not an elected position. It is a permanent position created by the founder of the club, Paul Cunningham. The president shall preside over all meetings, and meetings of protest, (unless involved per Article IX, Section C.) He will make decisions on his own if it is for the good of the club, unless it concerns a violation of a policy. If there is a violation of policy, then the club must vote on the matter and the majority club vote rules
2. The election of officers shall be held annually at a regular meeting scheduled in January. Nominations for all officer positions shall be decided by the club and take place at during meeting prior to, or after the season. The president will create the slate of nominees to be voted on. Any member in good standing may be nominated. Elections shall be by majority vote of all members in good standing.
3. Only a member with 1 year club experience in the Longview Bass Club can run for a board position, unless voted to abort by the current board.
4. Each member is entitled to one vote. Proxy votes are not permitted.
5. The term of each elected officer is for one year, which shall begin upon the completion of elections at the regular scheduled meeting in January. Original slate of officers shall serve until the last meeting of the following December.
6. Should an office become vacant, nominations will be solicited, and an election held for an officer to complete the unexpired term of the officer vacating office. The election will be held at the next club tournament or function.
7. Should any officer fail to fulfill their duties they may be removed from office. This shall require a majority vote of the Board of Directors/Executive committee. Charges shall be submitted in writing and the officer in question shall have the opportunity to defend all accusations.

ARTICLE XI... *Dissolution of Organization*

Remaining Assets

Section A:

1. In order for dissolution of organization to occur, the board must vote unanimously for dissolution. If passed, all remaining assets are to be used exclusively for exempt purposes, such as charitable, religious, education, and science purposes. Items and assets can be donated to other such clubs and organizations.
2. It is the final will of the club to help the community and better its surroundings.
